The meeting was called to order at 7:10 at the home of Bud Jenkins.

Motion made to approve the meeting notes from August 2008. This motion seconded. All were in favor so it carried.

**Roads and Zoning**: Rich reported that he received three requests to remove dead trees. Requests from 385 North Shore Road, 1151 Valley Drive and 413 Park Creek Court. Motion to approve. Seconded. All in favor. Rick also reported that the Dowling property had been mowed in the front, but had not been in the back. Rick will notify property owner. Rick would also like to thank Tim Fontaine for cleanup of the mailbox area in front of the Dowling property. It was reported to the County that construction clean up for 530 Edgewater has not been completed.

**Membershi**p: Denise reported that she received three additional memberships. Totaling 143 paid memberships to date. With a total of \$11,800 collected. This is slightly down from last year. Denise believes this is due to the number of Homes for Sale, and the few Deaths in North Shore. Denise also reported that in response to a Teen liaison. Megan and Bryan Nolan are willing to host a Teen Night at there home once a month.

**Park**: Bud reported that two new swings, including chains, and one new chain basketball net were installed at the playground. Thanks to Harry and Jerri Rupprecht. Total cost for

the high quality equipment was \$116. Thanks also to Denny Debus for helping on the drainage problem.

**Pier**: Rich reports that to date everyone is paid up on the slips. He would like to thank Marty Gavin for fixing one of the faucet leaks and will be addressing the other. He also reports that the dirt piles at the pier are from Wayne Bartholomee and they will be used for filling in the holes around the bulk heads. Anyone interested in volunteering, please give Rich a call.

**Entertainment**: At current Lisa has a total of 47 adult and 9 children tickets for the Annual Crab Feast. Discussion of Tropical Storm Hannah passing by on Saturday, required a decision to be made by Thursday on postponing the event till the following Saturday, September 13<sup>th</sup>.

**Beach**: Rick reported that under Old Business the grass cutting seems to be under control. Rick is also looking into having someone cut the grass at the Mountain Road sign and at the circle on Long Cove Road by the beach. Beach expenses totaled \$119.83 this was for four propane tank fills and an adaptor for the new style tanks. Invoices for grass cutting and Handy Johns were delivered to Bonnie Howatt. Correction to the August Barnacle Beach report regarding beach helpers: a thank you to Joe Krycia for helping with Beach Cleanup Day. There is one Beach Rental for September on the 7<sup>th</sup> by the Krycias.

Beach Clean-up day was a great success, the beach was in good condition for the Luau. Thanks go out to: Bill Paul for contributing his boat to help with the nettle net installation once again. Thanks to Ted Tepper for his help resolving the electrical issues. Rich would like to thank the following for their hard work: Rae and Richard Regula, Charlie Parsons, Sean Harris, Denny Debus, Brenda Deremer, Fran Kuhne, Carl Kuhne, Joe Krycia, Jeff Schell, Dave Pearson, and Dean Watts for his help earlier in the week.

Vandalism at the Beach...Update: It has been reported that a golf cart has been witnessed cruising the community in the early hours of Friday and Saturday nights between 3:00 and 5:00 AM.

Rick will have a volleyball sign made (same materials as Crab Feast sign) to replace the hand written current sign. Rick needs help installing adaptors on the propane tanks. And will talk to Bill Morris to see if he can help. Rick suggested moving the Volleyball court to higher ground so he can eventually put sand on the court with less chance of washing away. He will set new posts for cost of materials. The original court will then be used for badminton. A motion was made to go ahead with ordering a New Beach Sign for the Beach using the design and materials proposed last year. This sign matches the design at the entrance and park. The quote in 1/08 was \$1425.00. Motion seconded all approved so it carried.

**Garden Club**: There was no meeting in August. September meeting to be announced.

#### Crime in North Shore

In the last 3 months there have been several incidences of vandalism and robbery in our community.

The Beach property was vandalized on or about Aug 1 or 2, damaging the picnic benches, pavilion canopy, beach sign and port-a-potty. More recently the shed at the beach was broken into and some items stolen. In July a lawn tractor type vehicle was stolen from the driveway of a home on Edgewater. In mid-August, that same residence was broken into and items stolen from the garage. On the same night a neighboring house had items stolen from the carport and a car was broken into. The group responsible for the August break in was surprised by the homeowner who called the police and they were caught. The group caught was from a neighboring community.

On August 26 I wrote an e-mail to Captain Tom Rzepkowski Commander of the Eastern Police District telling him of these incidences and asking for more patrols in the North Shore Community and also asked what else we could do to prevent these incidences. He responded to me within an hour and said he made his patrol supervisory staff aware of our crime concerns "for patrol deployment tactical consideration". He also had the Police & Community Together (PACT) Sergeant Kathy Pleasant contact me which she did on 8/27/08. Sergeant Pleasant reminded me of the importance of locking the doors in our homes as well as vehicles. She also emphasized that we should call the police when we witness suspicious activity. She is available to attend community meetings to talk about working with police on crime prevention and reporting.

I have also had reports of non-residents fishing at the Beach and Marina. If you are at the Beach, Park or Marina and someone is not familiar ask them where they live or if they

are a guest of a resident and who that resident is. If they are not a resident or a guest of a resident then let them know this is private property and they must leave. Get a vehicle tag number if you can. If they are combative and/or do not leave call the police.

The Police Community Relations Council has a monthly meeting at Eastern Police

District. The meeting is held 3rd Wednesday of the month at 3700 Mountain Road, 7:30 p.m. I am planning on attending the Sept 17 meeting. Anyone interested can attend. Here is the website for more information:

#### PROPERTY OWNERS ALERT!!!

If your are a property owner in Anne Arundel County you will be affected by the Legislation before the County Council on Tuesday September 2nd, 2008

Bill 66-08 Property Line Setbacks. If your property is next to a County Park or Trail the County is basically going to take 50 feet from you without compensation or notifying you. There are over 8000 acres of park land in Anne Arundel; a lot of people are going to be affected.

Bill 67-08 Critical Areas More taking of property by Anne Arundel County without compensation or notification.

Bill 71-08 Impact Fees (Excise Taxes) If you want to make improvements to your property, new construction, additions or any improvement you must pay Impact Fees (Excise Taxes) which are going to be very, very expensive.
