Membership

Membership dues renewal forms have hit your mailboxes by now and people are starting to send them in. Please help the Association by sending in your dues now, thus reducing the cost of a second reminder mailing.

Some differences this year:

1—An increase in dues was ratified by members at the Annual Meeting in February. There has not been a dues increase in probably more than 15 years though our costs for maintenance, taxes, insurance and utilities have steadily risen during that time.

2—A new deadline has been established as April 1. Rock fishing season will start the middle of April and ramp keys and marina use will not be available until dues are paid. A little background here may be helpful. Our fiscal year runs from March 1 to February 28/29. The April 1 deadline gives a month grace period to pay. Of course we accept dues at any time but use of the community amenities is restricted to paid members.

3—A donation fund for marina dredging has been established and you will see a line on the membership form for this. Our marina is in dire need of dredging and bulkhead repairs which are going to be very costly. We are presently studying ways to pay for this and we know that donations will play a big part. Donations will be sequestered in a dedicated account and will not be used for general expenses. If you can help, it will be greatly appreciated. Even if you don't use the marina, consider that the marina adds value to all our properties.

North Shore Galley

Asparagus, Spring Onion, and Feta Quiche

Yield: Serves 6 (serving size: 1 slice)

Total time: 2 Hours, 30 Minutes

Ingredients

1 (14.1-oz.) pkg. refrigerated piecrusts
 2 tablespoons (1 oz.) salted butter
 2 cups thinly sliced spring onions
 1 bunch fresh asparagus, trimmed and cut into 1-inch pieces)
 2 teaspoons kosher salt, divided
 3/4 teaspoon black pepper, divided
 1 cup heavy cream
 8 large eggs
 2 tablespoons thinly sliced chives
 2 tablespoons chopped flat-leaf parsley
 1/8 teaspoon ground nutmeg
 3/4 cup crumbled feta cheese, divided

Preparation

1. Preheat oven to 425°F. Unroll piecrusts; stack on a lightly floured surface. Roll stacked piecrusts into a 12-inch circle. Fit piecrust into a 10-inch deep-dish, lightly greased tart pan with removable bottom; press into fluted edges. Trim off excess piecrust along edges. Line piecrust with aluminum foil or parchment paper, and fill to rim with pie weights or dried beans. Place pan on a baking sheet. Bake in preheated oven 14 minutes. Remove weights and foil, and bake until golden brown, 10 to 12 more minutes. Reduce oven temperature to 350°F. Cool piecrust completely on baking sheet on a wire rack, about 15 minutes.

2. Meanwhile, melt butter in a medium skillet over medium-high. Add onions, and cook, stirring occasionally, until tender and lightly browned, about 10 minutes. Stir in

asparagus; sprinkle with 1/2 teaspoon salt and 1/4 teaspoon pepper. Remove from heat, and cool 5 minutes.

3. Whisk together cream, eggs, chives, parsley, nutmeg, and remaining 1 1/2 teaspoons salt and 1/2 teaspoon pepper.

4. Place half of onion mixture (about 1 cup) in tart shell; sprinkle with 1/4 cup feta. Spoon half of cream mixture (about 1 1/2 cups) over feta. Repeat layers once, and sprinkle top with remaining 1/4 cup feta.

5. Bake in preheated oven until set, about 1 hour. Cool on baking sheet on a wire rack 20 minutes before serving.




