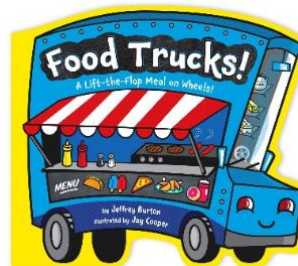
Jan 2021 Issue

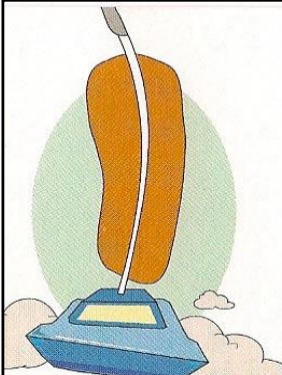
